ORDER

Subject: Compliance of Hon'ble Supreme Court Order Dated 04.02.2022 regarding payment of Ex-Gratia Assistance from State Disaster Response Fund (SDRF) to the Next of the kin of the deceased person due to Covid -19.


Hon'ble Supreme Court of India vide Order dated 04.02.2022 in Miscellaneous Application No.1805/2021 in Writ Petition (Civil) No.539/2021 titled as Gaurav Kumar Bansal V/s Union of India & Ors. regarding payment of ex-gratia assistance from State Disaster Response Fund (SDRF) to the next of kin of the deceased persons due to Covid-19 has inter-alia directed as under:

"State Governments to appoint a dedicated officer, not below the rank of Deputy Secretary in the Chief Minister Secretariat as a Nodal Officer, who should be in constant touch with the Member Secretary of the concerned State Legal Services Authority so that the Member Secretary of the concerned State Legal Services Authority may coordinate with him and see to it that the applications are received from the eligible persons".

Accordingly, Sh. Anil Sirohi (Deputy Secretary), Chief Minister Secretariat, Delhi is appointed as Nodal Officer for coordination with the Member Secretary, Delhi State Legal Services Authority in terms of direction of Hon'ble Supreme Court.

Further, Special CEO (Disaster Management), Delhi Disaster Management Authority (HQ) will also coordinate with CM Secretariat and Delhi State Legal Services Authority for sharing the data related to ex-gratia assistance from Delhi Disaster Response Fund (DDRF) to be paid to the kin of the deceased persons due to Covid-19.

This is issued with the prior approval of the Competent Authority.
